PROGRAM DESCRIPTION

Moldex3D Global Innovation Talent Award 2018 ("Contest"), organized by CoreTech System Co., Ltd. ("CoreTech System"), is an annual CAE simulation application contest designed to showcase the most innovative projects based on Moldex3D.

ELIGIBILITY AND GUIDELINES

- The Contest is open to all current CoreTech System customers/partners ("Entrant") using Moldex3D.

ENTRY REQUIREMENTS

To be eligible for judging, an Entry must consist of the following components and meet the following content requirements:

- Only Entries in English or Chinese will be accepted.
- All Entries must use predominantly Moldex3D Solutions and demonstrate the benefits/ values of Moldex3D.
- Entries that are incomplete or do not comply with these guidelines may be disqualified.
- IMPORTANT: All Entries submitted to the Contest are considered public and will be used for marketing purposes.

IUDGING

Entries will be reviewed by a judging panel consisting of top directors and executives from CoreTech System based on the following criteria:
